Resolution Recognizing the Ann Arbor Jaycees Foundation as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License

Whereas, P.A. 382 of 1972, as amended, requires that local civic nonprofit organizations be recognized by resolution adopted by the local governmental subdivision in which the organization conducts its principal activities and that a copy of said resolution be filed with any application for a license to conduct a bingo, raffle or charity game(s);

Whereas, Ann Arbor Jaycees Foundation has requested that it be recognized as a nonprofit organization operating in the community for the purpose of obtaining a charitable gaming license; and
